Sample Pet Agreement

1. Diagram of outside patio or area to be available to pet dogs. (Must be accessible without entering the facility.)

2. How will you assure that employees do not touch, pet or otherwise handle pet dogs (include written procedures)?

3. If any pet dog has an accident involving dog waste on the patio it will be cleaned using your vomit and diarrhea clean up kit and procedures. Attach written procedures for responding to a vomit and diarrheal event.

Sample Pet Agreement*

4. How will you notify employees and customers of the following requirements of GA Food Code (include written procedure and other supporting documentation/signage; *use additional paper if need*):
- All pet dogs must be on a leash and under supervision of the owner at all times;
 - Employees may not feed or touch your pet at any time;
 - Pets are prohibited come in contact with any dishes, utensils or tableware;
 - Pets are prohibited from chairs, tables, or other furniture;
 - Customers are prohibited from feeding pets while on the premises; and
 - At no time may pet dogs be permitted to travel through the indoor or non-designated outdoor portions of the food establishment.

A sign may be posted at the entrance of the outdoor designated area as a method of informing customers that pet dogs are allowed on the patio or deck. (See example sign: "Dogs are Welcome on Patio Only").

*These rules do not apply to service animals.

Dogs are Welcome in Patio Area Only

- 🐾 All dogs must be on a leash and under supervision of the owner at all times.
- 🐾 Employees may NOT feed or touch your dog.
- 🐾 Please do NOT feed your dog.
- 🐾 Please do NOT allow your pet to come in contact with any tableware.
- 🐾 Please prohibit pets from furniture.
- 🐾 At NO time is your pet allowed to come inside the facility or non-designated patio areas.
- 🐾 *These rules do not apply to service animals.*
